

**ARTICLES OF INCORPORATION  
OF  
BLUE GOOSE ALLIANCE**

**Article One: Name.** The name of this Corporation shall be:  
BLUE GOOSE ALLIANCE.

**Article Two: Duration.** The duration of this Corporation shall be perpetual.

**Article Three: Purpose.** The Blue Goose Alliance is a non-profit conservation organization, operating in compliance with Section 501(c)(3) of the Internal Revenue Code of 1986. The purpose of the organization is to educate the American public to the opportunities afforded by the National Wildlife Refuge System, and to alert the public to the organizational and physical needs of the System. The Alliance is dedicated to (1) elevating the stature of, (2) strengthening the integrity of, and (3) establishing maximum autonomy for America's National Wildlife Refuge System, thereby enabling the System to conserve wildlife and wildlands and to offer to the American public educational and recreational opportunities which are compatible with the primary purposes of the System.

**Article Four: Dissolution.** Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively to such organizations as qualify as a tax exempt organization under Section 501(c)(3), and whose aims and goals are similar to those of this corporation.

**Article Five: Registered agent & office.**

The registered agent shall be: Leslie Beaty

The registered office address shall be: 10 Circle S Rd., Edgewood, NM 87015

**Article Six: Directors.** The powers of the incorporators are to terminate upon filing of the Certificate of Incorporation.
